It is the responsibility of the registrant and attendee of WETC sponsored classes to participate in the class and to use the knowledge and skills presented to the best of their abilities. The WETC or the instructors for the classes or events shall not be held liable for exam outcome or result beyond the scope and duration of the class or presentation.

**Class Requirements:** The WETC reserves the right to limit the maximum number of registrations for any class or event. The WETC also reserves the right to set a minimum number of registrations necessary to conduct the class. Every effort will be made to conduct the class as promoted, however, the WETC will not be liable for changes of time, date, or location that are beyond the control of the WETC other than those stipulations set forth below.

**Class Cancellation:** The WETC reserves the right to cancel this class for any reason without prior notice. Every effort will be made to notify participants as soon as possible of a cancellation.
